St. Joseph's Pre-Season Holiday Invitational Double Elimination Basketball Tournament November 2018

1. The Tournament will consist of the following divisions:

7/8 year old boys	Cannot have reached the age of 9 before April 1, 2019 <i>AND only be in</i> 1^{st} <i>or</i> 2^{nd} <i>grade</i> $-$ <i>NO</i> 3^{rd} <i>graders in this division.</i>
7/8 year old girls	Cannot have reached the age of 9 before April 1, 2019
9/10 year old boys	AND only be in 1^{st} or 2^{nd} grade – NO 3^{rd} graders in this division. Cannot have reached the age of 11 before April 1, 2019
9/10 year old girls	Cannot have reached the age of 11 before April 1, 2019
11/12 year old boys	Cannot have reached the age of 13 before September 1, 2018
11/12 year old boys 11/12 year old girls	Cannot have reached the age of 13 before September 1, 2018 Cannot have reached the age of 13 before September 1, 2018

- 2. It will be a double elimination tournament starting Tuesday, November 6th, and completing on or about Thursday, December 6th, 2018.
- 3. A team may consist of more than (15) players from the same school or church; however, only(15)trophies will be awarded to the winning tournament team. A player may only play in one division in this tournament. Penalty will be losses for both teams.
- 4. The 7/8 year old divisions will play with an 8-foot high basket. The 9/10 year old girls will play with a 9-foot high basket. The 9/10 year old boys, 11/12 year old girls and boys (Junior Divisions), and the 13/14 year old boys and girls (Senior Divisions) will play with the standard 10-foot high basket.
- 5. A. The intermediate size ball (28.5) will be used in all divisions except the 13/14 year old boys division, where the regulation size basketball will be used.
 - B. <u>PANTS WITH POCKETS, EARRINGS OR BRAIDED HAIR WITH BEADS WILL NOT BE</u>
 <u>ALLOWED.</u> Parents should be notified of this requirement.
- 6. A. In the 9/10 year old girls division full court pressing will be allowed only the last minute of each half, if there is no greater than a (10) point lead. Penalty for this violation will be a technical foul. *There will not be a warning!*
 - B. In the 7/8 boys and 7/8 girls divisions the defensive line will be the gray line that is just past half court. The offensive team has (20) seconds to go from the baseline past the gray line on the other side of the half court line.
 - C. The defensive line will be at half court the last minute of each half if the score is not greater than (10) points.
 - D. Violation of this rule will result in a technical foul. There is NO warning!

- E. The clock will run after a 20 point lead. The clock will only stop on time outs or until the score gets back to a 15 point lead.
- 7. **MOST IMPORTANT:** *Each player must play each half.* The amount of time a player plays is a coach's call (clock must be running). Violation of this rule will be forfeiture of the game. Ensure that players notify scorekeeper when reporting into game. **Scorekeeper's decision is final on participation.** Penalty for nonplaying is forfeiture of the game.
- 8. Any player or coach ejected during a game by an Official will receive a one (1) game suspension. A second ejection at any time will result in permanent suspension for the remainder of this tournament and future participation at St. Joseph's. Ejection means off the bench, off the court, out of the gym (for coaches only ejected players will remain on the bench). All will sign and observe a Code of Ethics, parents and coaches.
- 9. All paperwork including *a copy of a player's birth certificate must be on file with the Tournament Director by October 24, 2018.* A declaration page is included for your convenience. There will be no exceptions to this rule!!!
- 10. Locker rooms are available for use. Visiting teams will use men's locker room, located to the right as you enter the gym and home teams will use the women's locker room, located all the way to the right past the seating area. Please leave the markers on the white boards so the next team can utilize them. Keep locker room clean.
- 11. ADMISSION: Admission to games will be \$2.00 per person. A concession stand will be operational.
- 12. Team awards will be presented to the First and Second place teams in each division with individual awards only to the First Place Team in each division and a MVP award voted on by the 1st place coaches.
- 13. Fee for the tournament will be \$110.00 per team except for the 7/8 Year Old Division, which the fee will be \$85.00.
- 14. Deadline for entry fee is Wednesday, October 24, 2018. Entries will be limited. Fees must be paid at this time. Checks can be made payable to AASTJ (Athletic Association of St. Joseph).

Dear Coaches,

- 1. Gym opens 30 minutes prior to the first game
- 2. NO coolers allowed
- 3. **DO NOT** approach scorer's table unless a time out or end of quarter
- 4. Check your roster/line-up sheet prior to game to ensure correctness
- 5. No balls will be provided for warm-up
- 6. After game please clear area so the next game can start

Remember: **DO NOT** embarrass anyone with the use of the scoreboard! (15) point press rule. The clock runs at a 20 point lead. Note:

7/8 Division – No score will be added to the scoreboard after a 10-point lead.
